**PUBLIC HEARING**

Public Hearing was called to order by Mayor Doug Cheek.

Mayor Cheek stated the Millage rate will be set at zero and asked for any comments. There being no comments the Public Hearing was closed @ 6:02PM

**REGULAR MEETINGS**

**MILLAGE RATE**

Sandra Garrison made a motion to set the millage rate at zero (rollback of 2.670). Cliff Hill seconded the motion and passed unanimously. (5-0)

**DERELICT PROPERTY**

Donald and Yemetrius Gantt, owners at 499 Scales Creek Road, discussed their plans for the property.

Mrs. Gantt read a statement that she had written regarding the plan for a homeless veteran's home in the existing doublewide, the storage buildings turned into greenhouses to teach the veteran's how to grow their own food, one of the RV's on the property will be their office space. Attorney David Syfan explained that zoning is in place and they need to come into compliance with the zoning ordinance. He suggested they draw up a detailed plan explaining everything they want to do on the property.

Sandra Garrison suggested they clean up the property and come back to the Mayor and Council with their plan. Mr. and Mrs. Gantt agreed to produce a plan and submit it to the Mayor and Council.
